Workstream 1

- It was agreed that the Parish Council would liaise with Councillor Harrison regarding the design of the Village Gateways to be installed in the Cheshire East part of the Parish.
- It be noted that these Village Gateways would be fully funded by Councillor Harrison using his Cheshire East Council Highways budget.

Workstream 3

- a. It be noted that work on the refurbishment of the phone box is complete.
- b. Payment of £196.18 for paint and silicone be approved.
- c. It be noted that work on the design of the information board is ongoing.
- d. Agreed that two further sets of Christmas tree lights be purchased at a cost of c £140 to replace those that failed last Christmas.
